### **17 - 3627 To receive a report from the Finance Working Group**

The budget papers for 17/18 had been circulated to all Councillors prior to the meeting and Councillor James provided a review of the draft proposals. The proposals indicated expenditure of £143,774 with a required precept of £130,870.

Based upon the information provided by Daventry District Council the proposal would mean an increase of £2.23 per year per household, based upon a Band D property. This was a 3.49% increase in real terms.

It was agreed that this report be recommended for approval at the Council Meeting to be held on 24<sup>th</sup> January 2017.

This was proposed by Councillor Coles and seconded by Councillor Brown. Unanimous.


