21/5629 Public Open Forum

Two members of the public were present and asked for information regarding the proposed Indoor Sports Project to which Councillor Bird gave an overview.

21/5630 Community Centre Indoor Sports s106 Project

A presentation was given by the chosen contractor on a proposal for indoor sports provision in the Community Centre. It was RESOLVED to place an order for the proposed scheme, with the ballet bars and mirrors removed, subject to West

Northamptonshire Council agreeing to release the s106 funding for the project. This was proposed by Councillor Bird and seconded by Councillor Lunnon. It was also **RESOLVED** to agree the following actions: to seek clarity on the proposed storage; have a £2,300 contingency; and to further explore the purchase and installation of a climbing wall. This was proposed by Councillor Bird and seconded by Councillor Spratt. It was also agreed that the parish council would be responsible for purchasing the table tennis tables, bars, mats and any other additional sports equipment separately. The contractor agreed to provide an estimate on the cost of a heating and ventilation system.

A report was received on VAT implications and it was agreed that this would be clarified with the independent VAT advisor.
