The Planning Committee debated concerns regarding the proposed design, rendering, access from the front to the back of the property, parking arrangements and it was noted similar properties had been extended in the immediate vicinity, in a similar manner. Concerns were raised over the size and positioning of the porch beyond the build line. The committee considered the difference the proposed build would make to the property and the residents.
